
Classic Series Models

Features and specifications are subject to change at any time without notice.





Electrical Requirements


Installation must comply with all applicable electrical codes.

International models from the factory require a 220-240 V AC, 50/60 Hz electrical supply, fused at the correct rating for the unit. If required by local or national codes, the power cord can be easily replaced using the power inlet device.


The electrical supply should be easily accessible and positioned either in a cabinet above the refrigerator, a minimum of 2200mm above the floor or in adjacent cabinet. If freestanding then locate the powerpoint as per the diagram below.

Plumbing Requirements

Installation must comply with all applicable plumbing codes.


For Classic Series models with an automatic ice maker, a pressure limiting valve and 5 metres of flexible 6mm pipe with fittings is included in the refrigerator carton. Connect the pressure limiting valve close to the water tap, checking the water flow is in the right direction. Ensure water connection is 1/2" BSP male threaded outlet. Fix the 6mm water line to the wall and floor to ensure it is not compressed when the refrigerator is pushed into the cavity.

The water tap should be easily accessible and positioned either in a cabinet above the refrigerator, a minimum of 2200mm above the floor, or in adjacent cabinet. The water line must not interfere with installation of the anti-tip brackets.


A reverse osmosis system can be used provided there is constant water pressure of 2.4–8.3 bar supplied to the unit at all times. A copper line is not recommended for this application.

Custom Panels

For flush inset applications, custom door panels must be provided. Handle hardware must also be provided for flush inset applications. Refer to Panel Requirements below and the charts on the follow-ing pages for custom panel dimensions for your specific design application.

Finish all sides of the custom panels. They may be visible when the door is open.

ICE AND WATER DISPENSER

For model ICBCL4850SD, the refrigerator door panel must include a cutout to accommodate the external dispenser. The bezel will accommodate a minimum 19 mm thick panel. Panels thicker than 19 mm must be routed to 22 mm in the dispenser area (31 mm) including the backer and spacer panels).



PANEL MOUNTING KIT

The Sub-Zero custom panel mounting kit eliminates the need for the backer and spacer panels and is available through an authorized Sub-Zero dealer.

The kit consists of mounting cleats, screws, and gauges used to properly position the cleats. The kit is available for all Classic series models except glass door models. Dual installations require two mounting kits.

Flush Inset Panels

The flush inset application is an overlay model with flush inset panels. It is not a separate model.

The flush inset design allows custom panels to be installed flush with adjacent cabinets. Flush inset panels are typically created by combining a 19 mm custom panel, a 3 mm spacer panel, and a 6 mm backer panel. Refer to the illustration below.


For flush inset panels thicker than 19 mm, a 90° door stop may be required to prevent interference with adjacent cabinets. Refer to the full-scale templates at the end of this guide.







Panel assembly (rear view)









Flush Inset Panels

FULL-SCALE TEMPLATE

Flush inset panels must be a minimum of 19 mm thick to support mounting the handle. Panel thickness does not include the backer and spacer panels. Mount the handle close to the opening edge of the door.

The benefits given by this Warranty are in addition to all consumer guarantees and other rights and remedies prescribed by the Australian Consumer Law and any other applicable laws

Our products come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

In addition to your rights and remedies under the Australian Consumer Law, Sub-Zero provides customers with a Warranty where, if any part of a Sub-Zero Product is found upon inspection by an authorised Sub-Zero representative or an associated licensed technician supplied by either Sub-Zero or a relevant approved supplier (including a Sub-Zero factory certified service) ('Service Representative') to be defective in materials or workmanship, Sub-Zero will repair or replace the part free of charge as follows:

FULL TWO YEAR WARRANTY* (**Outdoor product full one year warranty)

For two years from the date of original installation, this Sub-Zero product warranty covers all parts and labour to repair or replace, under normal residential use, any part of the product that proves to be defective in materials or workmanship. All service provided by Sub-Zero under the above warranty must be performed by Sub-Zero factory certified service, unless otherwise specified by Sub-Zero, Inc. Where the Service Representative is unable to identify any fault in the product, Sub-Zero may require the consumer to provide proof that the product is defective. For the avoidance of doubt, defective products or parts become Sub-Zero's property. Service will be provided during normal business hours.

FULL FIVE YEAR SEALED SYSTEM WARRANTY*

For five years from the date of original installation, this Sub-Zero product warranty covers all parts and labour to repair or replace, under normal residential use, these parts that prove to be defective in materials or workmanship: compressor, condenser, evaporator, drier and all connecting tubing. All service provided by Sub-Zero under the above warranty must be performed by Sub-Zero factory certified service, unless otherwise specified by Sub-Zero, Inc. Where the Service Representative is unable to identify any fault in the product, Sub-Zero may require the consumer to provide proof that the product is defective. For the avoidance of doubt, defective products or parts become Sub-Zero's property. Service will be provided during normal business hours.

TERMS APPLICABLE TO EACH WARRANTY*

The warranty applies only to products installed for normal residential use. This warranty does not cover any parts or labour to correct any defect caused by negligence, accident or improper use, maintenance, installation, service or repair.

CLAIM PROCEDURE*

- *Stainless steel (doors, panels, handles, product frames and interior surfaces) are covered by a limited 60-day parts and labour warranty for cosmetic defects.
- *Replacement water filters and air purification cartridges are not covered by the product warranty.
- **Full one year warranty applies to outdoor product. Product must be approved for outdoor use, designated by model and serial number.
